Hilton Indemnitees	Hotel, Hilton Domestic Operating Company Inc. and each of their respective its parents, affiliates, subsidiaries, directors, officers, partners, employees and agents.

Location Agreement	This entire Location Release and Indemnification Agreement including any exhibits and/or riders attached to it which are hereby incorporated into the Location Release and Indemnification Agreement.
Pictures and Recordings	Still and/or moving pictures, images, photographs, films, audio/visual recordings or videotape recordings.
Premises	The Hotel's property located at [FR. R. Kreuzwaldi 23, 10147 Tallinn]. Only recording of the tournament and related area is allowed. Recording inside the casino is only allowed if it is directly related to The Festival Series.
Production	Any use of the Pictures and Recordings for any and all purposes including but not limited to Producer's promotional, commercial media uses throughout the universe, television programming services and related social media platforms via the internet, in any media and by any means.
The Event Space	[1 st floor (all meeting area including meeting foyer, Staircase between Lobby and Meeting Floor, Several Guest rooms used by the attendees for interviews, terrace of TAB restaurant as part of Thursday Evening event].

LICENSES, RULES AND REGULATIONS: Producer represents and warrants that (i) it has and will comply with all rules and regulations, (ii) it has obtained and will maintain continuously throughout the term of this Location Agreement, or during any period work is performed relating to this Location Agreement, all necessary licenses and permits required by applicable governmental jurisdictions in order for the Producer to take Pictures and Recordings on the Premise. Producer agrees that it is Producer's sole responsibility to be aware of any licensing or permitting requirement and all applicable rules and regulations.

LIABILITY: In the event Producer violates this Location Agreement, Acroud will have the right to pursue all damages and remedies at law and Producer agrees that damages may not be sufficient to remedy the violation and in such case the Hotel will have the right to temporary and permanent injunctive relief.
